# **Quality Assurance Requirements**

Northwest College and Seminary is authorized by the Legislative Assembly of British Columbia to award theological degrees. You can read the act <a href="here">here</a>. Northwest is fully accredited by the <a href="Association of Theological Schools">Association of Theological Schools</a> in the United States and Canada and has candidate status for full accreditation with the <a href="Association for Biblical Higher Education">Association</a>. Our accreditation with these bodies means that we make ourselves accountable to these two associations that consist of peer institutions to help us follow established standards and best practices for delivering quality higher education. Northwest is also an <a href="Education Quality Assurance designated">Education Quality Assurance designated</a> institution in British Columbia. International students are eligible to enroll in our degree programs on study permits.

## **Admission Policies**

- For undergraduate programs Northwest requires academic records from your secondary (High School) education.
- For undergraduate degree completion programs (BACL and BACL Korean) Northwest requires a minimum of 30 hours of General Studies so academic records from all post-secondary education must be provided.
- For all graduate level programs (M.Div., MABL, MATS) Northwest requires academic records from all of your post-secondary education.
- For the Doctor of Ministry program Northwest requires a Master of Divinity or its equivalent, so those academic records need to be provided.
- To be admitted into the KDMN program, applicants normally are required to have a
  Master of Divinity degree with a grade point average of at least 3.0 (B average) and
  three years of ministry experience. Applications can be completed online on the
  Northwest website. Applicants are required to provide:
  - 1. Official academic transcripts for undergraduate and graduate degrees
  - 2. References
  - 3. A personal photo
  - 4. A summary of the applicant's conversion and vocational ministry experience
  - 5. An application fee (\$150 CAD)

Applicants may also be considered for admission if they have at least 72 semester hours of graduate studies that include the completion of a master's degree that reflects broad-based work in biblical studies, theological studies and ministry practice. The master's degree is required to have a GPA of 3.0 (B average) and all additional courses must have received a grade of at least a B or 3.0.

## **ACTS Programs**

Northwest cooperates with the Associated Canadian Theological Schools of Trinity Western University in offering some academic programs. For ACTS Programs:

- A bachelor degree from an accredited university or college with a minimum 2.5 GPA (on a 4.0 GPA scale).
- Two references in support of your application one reference from a pastor or spiritual mentor and the second as an academic or character reference.
- Transcripts from all your post-secondary studies. These should be sent directly from all
  your previous educational institutions to ACTS. Transcripts must be submitted in English
  or accompanied by a notarized translation. Non-North American transcripts may require
  a Canadian degree equivalency evaluation.

# **Language Proficiency requirements**

Students interested in Korean-language programs must be native speakers of Korean. If applying for an English-language program, students for whom English is a second language are required to provide an English Proficiency Score as a part of the application process. We require this to ensure that all students are ready to enter and excel in their programs. With this in view, the minimum English proficiency test scores required for Northwest programs are as follows.

## **Credential Assessment**

Northwest Admissions requires all applicants to provide official academic records (official academic transcripts) of all previous education. To be considered official, academic records must either be received in official envelopes, sealed and endorsed by the issuing institution, or be received via secure electronic delivery directly from the issuing institution. All academic documents must be provided in English (for translations see below).

- For undergraduate programs Northwest requires academic records from your secondary (High School) education;
- For undergraduate degree completion programs (BACL and BACL Korean) Northwest requires a minimum of 30 hours of General Studies so academic records from all post-secondary education must be provided;
- For all graduate level programs (M.Div., MABL, MATS) Northwest requires academic records from all of your post-secondary education;
- For the Doctor of Ministry program Northwest requires a Master of Divinity or its equivalent, so those academic records need to be provided.

#### Documents that are not in English

If your educational documents are not in English, they must be included with a complete word-for-word (literal, not evaluative) English translation from a Canadian-certified translator. If you are submitting your documents from outside Canada and cannot obtain a translation from a Canadian-certified translator, you may submit a translation from an official translator in your home country. This translation must also be completely accurate or Northwest Admissions will require a new translation from a Canadian-certified translator.

## **Services**

## Wellness Centre

# **Grading and Academic Standing Policies**

Each program has its own grading system. For CBTE programs, the grading rubric is posted <a href="here">here</a>. Grading rubrics for course-based programs are included in the course syllabi. Grades are available to students through the student portal.

## Academic Standing – Doctor of Ministry (Korean)

International students must be enrolled full-time in a Northwest academic program and maintain an acceptable GPA to be considered an International Student in good standing.

Northwest's Registrar reviews the academic progress of students at the end of each term.

Reviews take into account the cumulative GPA of students and assess student progress according to the following criteria:

- 1. A GPA equal to the graduation requirement for the KDMN program (3.0 GPA for course work and B- for the thesis project). This includes any courses transferred into the program.
- 2. Students with provisional admission similarly must achieve a minimum 3.0 GPA for any additional courses required.

Northwest's Registrar will notify the KDMN Program Director and Co-director if a student is below the minimum GPA requirements, who will use the following criteria to determine the next course of action:

- 1. How far below the GPA requirement is this student?
- 2. How far along in the program is this student?
- 3. Has there been any instance of academic dishonesty by this student?

## Academic Probation (KDMin)

With the above in view, if Academic Probation is determined to be the best course of action, the primary goal will be to restore students to academic success and to help them maximize their learning and growth. At the same time, Northwest sees it as a point of institutional integrity to not permit further registrations and collect further tuition fees from students who are not demonstrating the ability to complete the KDMN program successfully.

Possible measures to take with students who are struggling to flourish academically are as follows:

- 1. Repeat the course(s) affected
- 2. Take additional course work
- 3. Restrict their level of enrolment to help them carry an academic load within the limits of their own schedule and abilities
- 4. Require students to step out for at least one course cluster, and in some cases, not allow any further registration if a student has a poor academic track record (including a GPA significantly below the graduation requirement, such as more than 1 full point below the requirement) or has shown to be academically dishonest (e.g. has committed plagiarism).

In the case of a failed thesis project, once the processes outlined in the Thesis Project Manual for remediating core issues are exhausted, there are no further means available to the student for completing the program.

Once a course of action is determined, an interview with the student will occur and a letter will be placed in the student's file in order to keep a record of this meeting.

Note: Students on Academic Probation are not eligible for financial aid.

## Academic Standing – Bachelor of Arts in Christian Leadership (Korean)

International students must be enrolled full-time in a Northwest academic program and maintain an acceptable GPA to be considered an International Student in good standing.

Students in the *Bachelor of Arts in Christian Leadership (Korean)* must maintain an acceptable rate of progress in the program as well as an acceptable Grade Point Average to be considered a student in good Academic Standing.

Northwest's Registrar reviews the academic progress of students at the end of each term.

## Academic Probation (KBACL)

Students in the KBACL may be placed on academic probation if they fail to meet the established competency benchmarks or demonstrate insufficient progress toward program completion.

Academic probation serves as a warning and an opportunity for students to address academic challenges and improve performance.

#### 1. Competency Assessment:

Students will be assessed by their mentors no later than at the end of each term. If a student fails to meet competency benchmarks, they may be placed on academic probation. The competency benchmark is to submit 8 assignments within a given semester. If a student fails to meet this benchmark, mentors will engage with the student to identify any possible extraneous circumstances that may have prevented their achievement of the benchmark. If the mentors do not identify any valid reasons, they will report to the program director or the assistant director.

## 2. Insufficient Progress:

Students failing to make satisfactory progress, as defined by program timelines (see above), may be subject to academic probation.

#### Academic Probation Procedures

1. Notification: Students on academic probation will be notified in writing, specifying the reasons for probation and the necessary steps for improvement.

- 2. Academic Support: Students on probation will be encouraged to seek academic support services provided by the seminary, such as tutoring or additional resources.
- 3. Probationary Period: The probationary period will be one semester, and students must demonstrate improvement by submitting 8 assignments within that timeframe.

## Removal from Program Criteria

Students may be removed from the program if they fail to show improvement during the probationary period.

1. Failure to Meet Probationary Criteria: Students who do not meet the specified criteria for improvement during the probationary period may face removal from the program.

#### Removal Procedures

- 1. Notification: Students facing removal will be notified in writing, outlining the reasons for removal and any appeal processes available.
- 2. Appeal Process: Students have the right to appeal the removal decision. The appeal will be made to the Academic Dean and the process will include a letter providing details of their appeal.
- 3. Final Decision: The final decision regarding program removal rests with the Academic Dean. With the recommendation of the program leader the Dean will take into consideration the student's performance, circumstances, and any appeals made. The Academic Dean reserves the right to allow the student another probationary semester in which the benchmark remains the same (8 assignments).

## Reinstatement

Students who have been removed from the program may be eligible for reinstatement after a one year, contingent upon meeting specific conditions outlined by the academic administration.

# Medical insurance for international students taking the Korean language BACL or DMIN

Medical Insurance is mandated by the Province of British Columbia for all international students. Non-Canadian students living in Canada must enroll with BC Medical Services Plan in order to attend school. The website for medical insurance info can be found here.

International students (and family members) who are new to BC are required to sign up for interim health insurance, until MSP is active. If you are an American student living in the US and commuting for classes, you must ensure that your medical insurance extends to your travels to and from Canada.

## Medical insurance for international students taking course-based degrees

Medical Insurance is mandated by the Province of British Columbia for all international students. Non-Canadian students living in Canada must enroll with BC Medical Services Plan in order to attend school. If you are an American student living in the US and commuting for classes, you must ensure that your medical insurance extends to your travels to and from Canada.

# **Housing and Cost of Living**

Northwest/ACTS Seminaries does not have housing available for international students. Trinity Western University has a <a href="https://www.norm.nity.com/housing-website">housing website</a> that you can access to see what's available in the community. There may be very limited housing available on the campus for graduate students. The website will give you all the information you need, including a person to contact, so you can begin your search.

Due to a tight housing market with an approximately 1.5 to 2 percent vacancy rate, renting a 2-bedroom apartment in BC costs between \$1,800.00 and \$3,000.00 per month. Students should prepare to spend an additional \$1,500.00 to \$2,000.00 on living expenses. If you plan to rent housing during your studies, it is important to know that tenants have important rights regarding quiet enjoyment, dispute resolution with landlords, and housing security. # **Tuition & Fees Due Dates and Late Payment Charges**

CBTE Students are invoiced for tuition and fees two or three times each year with payments due on **September 1**, **January 1**, and **May 1**. Invoices will be emailed to the student's **@nbseminary.ca** email address prior to each payment due date and will include a link for online payment. Tuition & Fees are payable upon receipt of the invoice and before the payment due date. A late fee of 3% will be applied to any outstanding balance at the start of the second month of the term. Please note that failure to pay in full by the end of the second month of the term could result in immediate suspension from the online platform and a review of the student's continuation in the program.

# **Refund Policy**

## **Class Attendance**

Students are required to attend all class sessions. Attendance is tracked by instructors and records are filed with the Academic Coordinator. Students who do not attend class are considered non-participants in a course and are subject to reductions in their grade.

# **Dispute Resolution**

For routine or minor disagreements, we encourage students, staff, and faculty to follow the principles for dispute resolution outlined in Matthew 18, to work together in seeking resolution to points of tension or disagreement. Students can appeal any decisions and/or actions concerning academic matters (e.g. grading) concerning a class, classes, outcome, and/or outcomes part of their course-based, CBTE, English, Korean, French, and/or Spanish program associated with Northwest.

In cases where a student in a Northwest program wishes to appeal a grade, assessment, or other treatment by an instructor, the student may appeal to the Academic Dean for investigation and resolution. The appeal must include all relevant details such as specific times, places, course assignments, and any other evidence that indicates the instructor is treating the student unfairly. In cases involving a Northwest student in an ACTS program, an appeal can be initiated by completing this form and sending it to the ACTS Academic Director, the ACTS Academic Success Committee.

If a student is making an appeal, they are required to provide context and rationale(s) for their appeal, and be willing to respond via email or in person to any questions, comments, and/or

suggestions made in response to the appeal. If a student's appeal concerns a grade (or grades), they must be initiated no later than sixty (60) days after the grade (or grades) in question have been issued.

For disputes related to non-academic matters, students are encouraged to first speak to those involved directly in the hopes of resolving the issue privately. However, this is not always possible or safe. In such cases students may bring the matter to the Dean of Students, who will work with the parties involved to find resolution. For matters related to bullying, harassment, sexual harassment, please see the "Bullying, Harassment and Sexualized Violence Policy" in the student handbook.

# **Employment rights and conditions in British Columbia**

International students can work up to 20 hours per week off campus. This includes any practicums or internships that are a requirement of your academic program. Employers must follow government standards for terms of employment, employee safety, working conditions, minimum wage, statutory holiday pay, and other important matters.
